If a loose pet bites anyone, they will be caught and turned over to Animal Control, and all owners will be responsible for any medical damages. If a loose pet does any property damage, the owner will be held responsible.

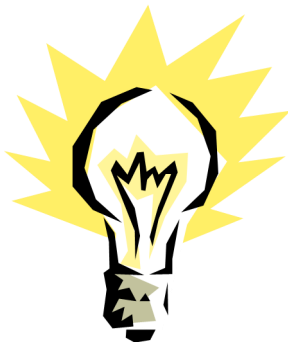


Bits and Pieces

Crystal Lake consists of 408 sites; 67 are mobile home sites, which the office sits on one; and there are 341 RV Sites. We have 207 permanent RV units with 90 transit sites and 44 rental units. Of the 90 transit sites, we have 14 sites that never seem to get used because most of the rigs on the road are too big for them. We also have 26 unusable sites that are too small or are being used with another unit that are not included with the 408 site count..
