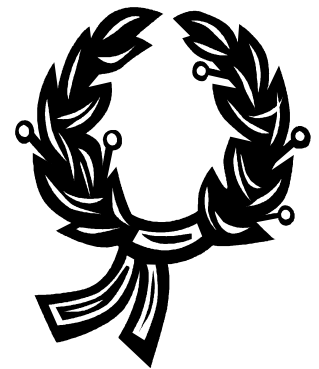
RESIDENT NEWS...
